Of course, we are a group of gifted genealogists so members Maureen Lee, Dot Brown, and Don Ouellette present the program on the spur-of-the-moment. Maureen Lee presented information on how her family immigrated from Eastern Europe. They came through Ellis Island. Maureen advised us to be cautious about surname spelling as there are many different ways to spell a surname. A good reference for immigrants who came through Ellis Island go to ellisisland.org.

Dot Brown's presentation was on "Removes". Dot's format showed how you trace your 1st cousin once removed, 2d cousin on removed, etc. Surnames – Western World Names come from four sources: 1-Patronymics – Williams, 2-Occupational – Miller/Fleche/Cook/, 3-Place (where they lived) – Fields/At Water/Woods and 4-Nick Names – Crank Shaft.

Don Ouellette discussed a PBS series on NOVA about animals and people in water caves. Archeologist took a tooth for testing which indicated it was from 13K years ago.

Introduction

To answer the age old question in genealogy, "Just what is a second cousin twice removed?" This chart courtesy of Dave Faithful. For a true "relationship" to exist, there must be an ancestor who is common to both individuals. If you examine the chart below, for example, the Common Ancestor is box 1 on the horizontal scale as well as box 1 on the vertical scale.

Let us suppose that you have a great grandson of that common ancestor, as seen in box 4 of the horizontal scale, and you want to know that great grandson's relationship to a great-great-great granddaughter, who is seen in box 6 on the vertical scale.

If you follow box 4 down to where it meets line six, it tells you the relationship - they are second cousins twice removed! My thanks to Dave Faithful for this illuminating piece of work. Now you know!

Short Takes excerpts from 'Family Tree Magazine' Aug 2006 pg58

You're not ready to take on writing the entirety of your clan's history, but you still want to preserve family lore or put your research discoveries into historical context. Here are five quick ways to share your story:

- * Family history journal: Keep a diary of your genealogical discoveries and how you feel or what you thought about them.
- *Photo narratives: Pick favorite photographs and write down everything you know about them—names of the people pictured, the event shown, the location.
- * Family atlas: Put maps and photos of your ancestral towns into a book or album, and add details about the locales, ancestors who lived there and historic events that took place in the area.

*Legacy book: Fill in a pre-printed book with information about your life and your family tree, or use the prompts as a springboard for your writing.

*Web site: Use your genealogy software or a free hosting service, such as Tripod <tripod.lycos.com. or Geocities <georcities.yahoo.com>, to plant your family tree online. Include photos, scanned records, descriptions and GEDCOMS. - Allison Stacy

David is a Fellow of the Utah Genealogical Association and the Irish Genealogical Research Society, London and is currently an instructor for the British Institute where he also serves as a Trustee of the International Society for British Genealogy and Family History. He currently serves as the VP of Development on the Board of the Federation of Genealogical Societies.
